Abstract: Through the years the city of Cartagena has been characterized as one of the most important and well-known tourist sites in Colombia, outstanding in many aspects and with a varied tourist offer, but it has also been seen that even with this wide offer They have a space aimed at people who have a type of physical disability. The goal of this research is to identify the challenges that the Historic Center of Cartagena faces as a tourist destination for people with reduced mobility, as well as to identify the regulations and laws that apply at the national level for the inclusion of people with reduced mobility in accessible tourism. Likewise, determine the main needs of people with reduced mobility in the development of tourist activities in the Historic Center and finally describe the current conditions of the physical infrastructure and tourist establishments in the Historic Center, in relation to the provision of services and the needs of people with reduced mobility.

INTRODUCTION

Accessible tourism is considered as one that specializes in designing trips adapted according to the type of disability and needs of each person. That is, it must be free of physical barriers, communication barriers and social barriers" (Lindsay, 2018). From this emphasis this project intends to adhere to the development of scientific research to face the challenge that this derives within this type of tourism that is currently one of which has been on the rise exponentially in recent years, due to the importance that it has been given in all fields to inclusiveness.

JUSTIFICATION

Tourism for all, is considered where all the aspects that must be taken into account to attend accessible tourism are specified. Considering the purpose of this investigation, it is determined that this tool has been prepared with the aim of being very useful and beneficial for businessmen in the tourism sector and that, from the execution of the manual, changes are generated in facilities, information, communication and attitude for the benefit of all people, especially those with disabilities, so that they can access services that meet their needs or expectations.

This research aims to identify the challenges faced by the Historic Center of Cartagena de Indias as a tourist destination for people with reduced mobility, in order to demonstrate these challenges it is necessary to identify the regulations and laws that apply at the national level for the inclusion of people with disabilities. reduced mobility in accessible tourism, as well as the research team seeks to determine the main needs of people with reduced mobility in the development of tourist activities in the Historic Center and finally describe the current conditions of the physical infrastructure and tourist establishments of the Historic Center, in relation to the provision of services and the needs presented by people with reduced mobility.

- 3. Show the deficiencies that affect a structure in body function; in the limitations of said activity as difficulty to execute actions or tasks, and their restrictions in the participation of vital situations.
- 4. Modify tourist products so that they can be enjoyed by anyone with some type of physical disability.

CONCEPTUAL FRAMEWORK

In the Rights of Persons with Disabilities (UN, 1975) it is stated that "The disabled must enjoy all the rights set forth in this Declaration. These rights must be recognized for all disabled persons, without any exception and without distinction or discrimination", since they are the fundamental basis for initiating the global action program for persons with disabilities, approved by UN resolution 37/52 (1982). As also the World Health Organization (2011) considers that "Disability is a general term that encompasses impairments, activity limitations and participation restrictions. Cartagena de Indias, a city with a tourist vocation, presents visible shortcomings that prevent the development of accessible tourism, which unfortunately, in the Historic Center of the city of Cartagena de Indias is an area almost unexplored by service providers. tourist, this is because the city does not have the necessary adaptation of the infrastructure to guarantee the free development of the tourist exercise, in a professional way, they do not take the city into account when planning a trip.

METHODOLOGICAL DESIGN

The research methodology used for the development of this work was qualitative and descriptive research. To obtain the information, the research team carried out field work touring the Historic Center of Cartagena, interviewing 7 tourist establishments and a family that was taking a tour of the city with a member with reduced mobility. A photographic record of the conditions of the streets was made and the information in documents and research articles is also tracked. Due to the effects of the SARS-COV-2 pandemic, it was impossible to cover a significant number of tourist establishments.

REGULATIONS CHAPTER I. AND **LAWS APPLICABLE AT** THE **LEVEL NATIONAL FOR** THE **INCLUSION** OF **PEOPLE** WITH REDUCED MOBILITY IN ACCESSIBLE TOURISM




Figure 1. Needs presented by people with reduced mobility in tourist activities., 2021.

The right to tourism is of vital importance for the full realization of individuals, being able to enjoy all the wealth that the planet has, allows strengthening aspects of the human being, such as interpersonal and social relationships, the acquisition of knowledge and the Being able to live significant experiences contribute to the development of new options within the tourism industry that do not interrupt the participation of all individuals regardless of their physical conditions. According to the accessible tourism manual "tourism for all" (2019) "One in three people does not have the basic and minimum accessibility conditions to carry out their daily activities, tasks and trades in a dignified and autonomous way, with greater difficulty they experience the inaccessibility of places, spaces, services or when they move from their close or habitual environment and make a trip, walk, tour". Figure 1 represents the basic needs of people with reduced mobility.

In general terms, Cartagena de Indias must have the political will to invest in the adaptation of the streets of the Historic Center and support for companies in the sector to train human talent so that they can offer a professional service to attend tourists who present this reduced mobility type of disability.
